Long Term Care

Determine eligibility for Financial and Benefit Support

- □ Contact DRC (Disability Resource Center) also known as the ADRC (Aging & Disability Resource Center)
- Complete an application for long-term support and benefits eligibility. The DRC will get you connected with someone to walk you through which long-term support options are best for your family (ie. IRIS vs. Family Care). The DRC will also have the most up-to-date service providers for Adults including options for adult day centers, independent living, etc.
 - ☐ Can call at age 17 yr. 6 months. Will complete a functional assessment to determine long-term care funding
 - DRC: <u>www.dhs.wisconsin.gov/adrc/index.htm</u>
 - They will set up an appointment to do a functional screening
 - Once approved, they will walk you through the process of choosing Family Care or IRIS

Disability Benefit Specialist and Social Security Benefits

- The ADRC also has a Disability Benefit Specialist that can provide services. They can provide
 information and assistance with the social security application and appeal procedures as well as
 Medicare/Medicaid, prescription drug assistance, FoodShare, low-income tax credits, insurance
 issues, housing and utility issues, and veteran's benefits.
 - ★ This is an important process, as it will help determine how many hours an individual can work before losing benefits.
 - It's a <u>free service</u>.

Work Experiences

Division of Vocational Rehabilitation - DVR

Can apply two years before leaving high school. If a student qualifies, they can receive assistance with achieving long and short term employment and career goals.


